Dr Oosthuizen obtained his PhD degree at Stellenbosch University in 2014, with the subject of his thesis "Modelling the financial vulnerability of farming systems to climate change in selected case study areas in South Africa". He was appointed Lecturer Extraordinary in the Department of Agricultural Economics, Stellenbosch University (2017 – 2020). He has acted as external examiner / moderator for Stellenbosch University, University of the Free State and Nelson Mandela University.

Dr Oosthuizen has been involved with the Water Research Commission (WRC) for many years as researcher on several projects. He was also nominated as Reference Group member responsible for oversight of two research projects of the WRC.
